Dear Parents / Guardians,

The school is in the knowledge of the order dated 13th October 2020 passed by the Hon'ble High Court of Calcutta in the Writ Petition WPA 5890 of 2020. The School, as advised, is taking steps to file an SLP to the Hon'ble Supreme Court against the said judgment and order dated 13th October 2020.

In the meantime, Parents are requested to pay fees in accordance with the order of the Honourable High Court of Calcutta dated 13 October 2020, which will be accepted by the School without prejudice to its rights and conditions. The excess fee, if already paid, will be adjusted in the coming months.




Special Request to Parents and Guardian:
